- 3) Assumes all the stated and all other risks and accept personal responsibility and financial responsibility for the damages following such injury, permanent disability, or death through personal or team insurance and/or personal financial resources.
- 4) Releases, waives, discharges, and covenants not to sue the any and all Cities and School Districts , FCS Ball, John Graham, their respective administrators, directors, employees, agents, coaches, and other employees or vendors of the organization, other participants, sponsoring agencies, sponsors, advertisers, and if applicable, owners and leasers of the premises used to conduct the event, all of which are hereafter referred to as "released" from any and all liability to each of the undersigned, his or hers heirs and next of kin for ant and all claims, demands, losses, or damages on account of injury, including death or damage to property, caused or alleged to be caused in whole or part by the negligence of the release or otherwise.
